## FOUNDATION HISTORY

Alpha Delta State Ohio, now known as Ohio State Organization (OSO), was the originator of Alpha Delta State Ohio Educational Foundation (ADSOEF). Members at the 2017 State Convention approved the establishment of the Foundation. Subsequently the A. Margaret Boyd Overseas Foundation organized in 1981 was renamed Alpha Delta State Ohio Educational Foundation.

Alpha Delta State Ohio Educational Foundation is recognized as a non-profit 501(c)(3) private charity that began operation July 1, 2017. The Foundation provides funding that supports international studies and good will, and promotes educational excellence by providing scholarships, grants, fellowships and awards for the professional and personal growth of educators.

ADSOEF is managed by ten Directors. The first election was March 2017 at the OSO Convention General Session. Beginning in 2023, and yearly thereafter, five Directors will be elected for two-year terms. Beginning with the 2021 election, the President of OSO was invited to serve as ex-officio, non-voting member of the Board of Directors. The Board elects a Chairman, Vice-Chairman, Secretary, and treasurer annually.

The official logo designed by Heather J. Storer, Alpha Chi Chapter, was revealed at the 2018 ADSOEF Annual Meeting. ADSOEF Bylaws were originally approved at the 2017 Annual Meeting. Starting in January 2022 our first newsletter was published electronically. Following a contest the newsletter was named, *Foundation Matters* in July. Carol Dunlap, Alpha Eta Chapter, submitted the winning entry.

In 2019 Florence L. Woodward made a major contribution for member scholarships to be awarded in her name at Kent State University. In 2023 through a major bequest from Jane and Dorman Stein, The Jane Brundige Stein Scholarship/Grant was established for education and nursing students at The Ohio State University Marion Branch.

All members of OSO are also members of ADSOEF and can participate in the Annual Meeting, serve on committees, volunteer for special activities, and serve as a director. No membership fee is required to be a member. Through the generous support of its members, ADSOEF is truly ***funding the future of excellence in education.***

The mission of ADSOEF is to provide funding to serve charitable purposes relating to professional and personal growth of educators and to promote educational excellence.

## Annual Meeting Rules of Order

In addition to the ADSOEF Bylaws and Meeting Policies and Procedures, the following Rules of Order shall apply to the ADSOEF Annual Meeting. Otherwise, *Robert's Rules of Order, Newly Revised*, 12th Edition, is the governing parliamentary authority.

The official prepared agenda shall constitute the Order of Business, subject to possible change by agreement of the members. The presiding officer may change the Order of Business, if deemed advisable.

Each meeting shall be called to order at the designated time.

The voting body is comprised of members of Ohio State Organization, thus ADSOEF.

Those members in attendance at the meeting shall constitute a quorum.

A member should refrain from speaking unless recognized by the presiding officer.

When a member has been recognized to speak, she begins by stating her name.

Each motion shall be in writing, signed by the proposer, listing the second, and sent to the presiding officer.

The member making the motion may speak first.

No member shall speak a second time on a matter under consideration until all others who wish to speak have had the opportunity to do so by common consent or the consent of the presiding officer. Each member may speak no more than two (2) times.

Members shall be called upon to speak alternating between those "pro" and "con".

June 11, 2022

Approximately ninety-nine members were present for the 2022 Annual Meeting.

Chairman Dr. Norma Kirby called the meeting to order at 10:34 a.m.

Joyce Jones-Weinkam, Gamma Xi, served as Parliamentarian for the meeting and reviewed the Rules of Order. The Rules of Order were adopted without objection.

**Approval of Minutes**

The Minutes of the 2021 ADSOEF Annual Meeting were approved as electronically distributed.

**Treasurer's Report**

Dr. Lois Harkins referred to the financial portion of the Annual Meeting Report for members to review. It was noted that a total of approximately \$19,000 was distributed for projects and programs.

It was reported that finances are in very good order. The CPA was hired for a fee of \$750. A better understanding of how to use the distribution of monies formula required by the IRS was explained.

Dr. Harkins also shared that various contributions with touching tributes honoring women in education were received.

The Treasurer's Report was filed for audit.

**Committee Reports**

Millie Holzer, Finance Committee Chairman, commended Dr. Lois Harkins for her detailed work.

Sandy Royer, Fundraising Committee Chairman, reminded attendees of the traditional luncheon giving opportunity. As of June 9, 2022, a total of \$11,790.83 had been raised during this year's fundraising campaign.

Jackie Thase-Burch, Marketing Committee Chairman, referred to the Annual Meeting Report and reminded every one of the Foundation's electronic presence on Facebook and the newly added QR code on documents for donations.

Dr. Norma Kirby referred to the Annual Meeting Report and recapped the Donor Relations Committee work chaired by Debra Frazier.

Chris Snoddy, Educational Services Committee Chairman, shared that there were grants available for Leadership, Lifelong Learning, and Individual/Classroom/Community Projects. To date, five Individual/Classroom/Community Project grants have been awarded. Two grants from the Lifelong Learning Fund have been given. The grant period in this report ran from June 2021 to June 2022. She encouraged everyone to apply.

Marilyn Slusser, OSO Scholarship Committee Liaison, reported that there were fifteen Esther H. Strickland student teaching grants for the 2022-23 school year, the most ever awarded.

Marilyn Slusser introduced the A. Margaret Boyd Overseas Fellowship recipients, Gunel Alasgrova, Kent State University graduate; and Brenda Rojas, Ohio State University student and recipient of a fellowship extension. Both recipients spoke of their gratitude for the fellowships and the love and support shown to them by OSO/DKG members.

In mid-July Della Kartika-Sari from Indonesia, current A. Margaret Boyd Fellowship recipient, will begin her studies at the University of Cincinnati.

Karyn Kern-Lazear, Governance Committee Chairman, reported that the Bylaws are up-to-date. Beginning in July, the committee will be reviewing the ADSOEF Policies and Procedures to ensure they meet the needs of the organization.

Karyn Kern-Lazear, Nominating Committee Chairman, reported that the committee will begin work in August to secure nominations for Board of Director members to fill vacancies including the vacancies of two directors who are term limited. Please contact Karen Kern-Lazear with names of potential candidates.

### **EDUCATIONAL SERVICES COMMITTEE**

This committee oversees awards in three areas: **Individual/Classroom/Community Project Fund, Leadership Development Fund, and Lifelong Learning Fund.**

Three **Individual/Classroom/Community Fund** awards were approved. An award went to the Girls Club Life Skills Project at Elm Street Elementary School in Painesville, as submitted by Hannah Fairbanks, Gamma Theta. Two teachers started a Girls Club for 4th and 5th graders. They will teach life skills with purchased supplies. The goal is to increase the girls' practical skills, their self-esteem, and their ability to help their community. The second award went to Beta Rho Chapter to purchase and stock two Little Free Libraries in Circleville, plus provide newspapers and books for a food pantry, and the Women and Children's Refuge. Marcia Smith, project leader, collaborates with Beta Rho Chapter's Literacy Committee members. Inspiration Station, a free, after school tutoring program in Norwalk received the third award. Nonfiction books for an on-site library will be purchased to strengthen English literacy and increase students' reading comprehension. JoAnn Krock, Zeta, is the project Leader.

A **Lifelong Learning** award was provided for the 2023 Biennial Seminar, History in the Hills. OSO President Debby Canter is coordinating the event, and funds will provide a bus for transportation to the various tour locations in Gallia and Jackson Counties.

This committee's members look forward to having more applications submitted for all three awards, to fulfill the mission of ADSOEF to "... serve charitable purposes relating to professional and personal growth of educators and educational excellence." Committee members can assist you in applying. Applications may be submitted at any time during the year.

## FINANCE COMMITTEE

The Finance Committee knows first hand the meaning of lifelong learning! We see changes in earnings, opportunities for giving, and new ideas for educational assistance.

Investments for the 2022-2023 fiscal year declined. However, we found a silver lining behind the cloud! We received a very generous donation from the will of Dorman and Jane Brundige Stein, a loyal Delta Kappa Gamma member. The investment of these funds will provide revenue for grants and scholarships at the Marion Branch of The Ohio State University for students in education and nursing.

Keeping in mind that a financial requirement of a Private Charitable Foundation is “a minimum of 5% of asset holdings are distributed each year,” we prepared the 2023-2024 Budget. ADSOEF treasurer carefully monitors the Total Assets as well as the Income and Disbursements. Using the total assets of each month, she averaged the total assets for 2022. That gave the committee a number to use for setting a Budget for ADSOEF.

Of course, a budget is only a guideline. If a request for an expense arises that is substantially more than the budgeted amount or that is not included in the budget, the request will be considered by the Finance Committee before approval by the Board.

We continue to support Purposes 3, 5, and 6 of The Delta Kappa Gamma Society International with income from sound investments and generous donations.
